In consideration of being allowed to participate in any way in the 2008 USLA National Lifeguard and Junior Lifeguard Championships, an athletic/sports event, which includes related event activities, the undersigned acknowledges and fully understands that each participant will be engaging in activities that involve risk and the potential for serious injury, including permanent disability and death and economic losses which might result not only from their own actions, inactions or negligence, but the action or negligence of others, the rules of play, or the condition of premises or of any equipment used; and that there may be other risks not known or reasonably foreseeable at this time; and that the undersigned's participation is voluntary and agrees to:

- Assume any and all risks of personal injuries to myself, or the minor, which are in any way related to the event, including but not limited to practice for the event, and authorize local emergency medical services to render any medical treatment that may be deemed necessary for me, including transportation to a hospital. I (we) give authorization to a licensed physician or surgeon to provide care and emergency medical treatment when necessary to me, or the minor. I (we) agree to pay all costs related to emergency care, transportation, and treatment caused by or arising from participation in the event or activity.
- Release, waive, discharge, and covenant not to sue the United States Lifesaving Association and its officers, members and chapters, or the Los Angeles County Lifeguard Association and its officers and members, or the Los Angeles County Fire Department and its employees, or the Department of Beaches and Harbors and its employees, or any sponsors, volunteers, contractors, or employees of the event, or the City of Manhattan Beach and its employees, or the State of California and its employees, or other participants, sponsoring agencies, or advertisers, all of which are hereinafter referred to as "releasees," from any and all liability to the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise. Agree that prior to the minor's participation in the event or activity, I or the minor's parents/guardians will inspect the facilities, equipment, and areas where the event or activity is being conducted and if either of us believe any of them are unsafe will immediately advise the person supervising the event, activity, facility, or area, and will discontinue participation until the unsafe condition is resolved.
- Grant the releasees the right to film, photograph or videotape the undersigned during the event which extends to all phases of publicity, promotion and advertising.
- Warrant that the participant is in good health and has no physical condition that would prevent the minor from participation in the event or activity.

I/We have read the above waiver and release, understand that we have given up substantial rights by signing and sign voluntarily.
